Dear Friend of Daniel Chapter One:

We are writing to you as a **friend** of the Daniel Chapter One ministry, and as a person who has purchased and used at least one of the **nutritional and herbal products** (Bio*Shark, 7 Herb Formula, GDU, or BioMixx) which we have developed. We trust that you are among the many people whose health has been helped by these products.

First, please know that we are not writing you about any problem with any of these products. In the 27 years of its healing ministry, Daniel Chapter One **has never ever received even one complaint** that someone was harmed by any of its products. Rather, we have received **countless testimonials** that people have been restored to good health.

But the world system does not always **commend the good**, as it should. 1 Peter 2:14. Sometime it unjustly attacks and **persecutes those that do good**. 2 Timothy 2:12. For the past year and a half, we have seen exactly how this can happen in America.

During this period, the Daniel Chapter One (“DCO”) ministry has found itself under attack by a powerful and unelected federal government agency — the **Federal Trade Commission** (“FTC”). DCO has been forced to spend tens of thousands of dollars in attorney fees and costs to defend itself in a process that most Americans would not believe could happen in the United States of America. Based on what DCO has experienced, it is no wonder that millions of Americans in the **Tea Party Movement** believe that government is out-of-control.

Let me tell you something of what is going on. The FTC is criticizing how DCO has described our products. But **you would not believe** how they came to that conclusion.

First, the FTC has acted against DCO even though it knows of **not one person who was harmed** by DCO products. The FTC had evidence of **not even one complaint** against DCO. The position of the FTC bureaucrats is that they don’t care what ordinary people think — they know better.

Second, the FTC has criticized how DCO has educated the public about the products it offers, not based on the words used by DCO, but **based on the subjective impression** that FTC bureaucrats and lawyers have about what we say about our ministry and products.

Third, although the law authorizes the FTC to challenge only “untruthful” or “deceptive” advertising, the FTC admits that it **did not even try to find one sentence of our advertising to be, in fact, “untruthful” or “deceptive.”** Rather, the FTC took the position that DCO is required to spend tens of millions of dollars that we certainly do not have to produce FDA-type drug studies, treating our herbal and nutritional products as if they were toxic drugs.

Fourth, the FTC has relied on the opinion of **one medical doctor**, who no longer treats patients, who makes his living running expensive chemotherapy studies, and who was so ignorant about herbal and nutritional medicine that he **didn’t even know if an “herb was a plant.”** And it is this one doctor, who knows nothing of herbs or nutrition, and who makes his living from the pharmaceutical industry that regularly poisons Americans, who is given the power to sit in judgment of the DCO ministry. This makes no sense.¹

Fifth, the FTC has not only tried to **silence DCO**, but also **silence people like you.** The FTC wants to **prevent sharing testimonies** from those whose health is improved by DCO’s products. Even though testimonial evidence is demonstrated in Scripture to be the way God establishes truth (e.g., Deut. 17:6), the FTC wants to silence those helped by DCO’s products.

In short, the FTC doesn’t want DCO (or any other seller of herbal or nutritional products) to be able to describe what our products do to improve health, unless DCO can present evidence to the FTC that its medical doctor believes in. Till then, the FTC has ordered the **muzzling of the DCO ministry** — to stop making any health benefit claims not only of the above-named supplements, but all of the dietary supplements that we have offered over the years.

Although we have taken the FTC to a **United States Court of Appeals** to reverse this order, we have not been successful in our effort to stop this order from taking effect BEFORE we have had an opportunity in court to prove the FTC order to be illegal and unconstitutional.

Here is what the FTC has ordered DCO to do.

1. Just a few weeks ago, DCO was forced to **turn over your name and address** which appeared on our “customer list” of persons who had purchased one or more of the above-named dietary supplements as far back as January 1, 2005. We are sincerely sorry that we had to do this, but felt that we had no choice.

¹ According to statistics published by the Journal of the American Medical Association, FDA-approved drugs have killed thousands of people, but they are still offered for sale. The truth is that establishment, conventional, allopathic medicine is ill-suited to the treatment of chronic, terminal illnesses, like cancer — often imposing “technological violence” through treatments, such as chemotherapy and radiation therapy — which “sets the stage for the advent of another [disease], perhaps even more cruel than the death one has just averted.” See Michael H. The government is not going after you for using a DCO product. But we want to warn you that **you may get a letter from BIG BROTHER**. We have no idea what that letter will say, but we wanted you to warn you, and let you hear our side of the story. Why does the government need your name and address? Whatever happened to privacy in America?

2. The FTC's order also **requires us to send to you a letter** stating that our four dietary supplements have not been scientifically proven to be effective in fighting cancer whereas the toxic cancer treatments approved by the FDA and sold by **Big Pharma**, where the medical doctor who testified against DCO makes his living, "have been scientifically proven to be safe and effective." These statements are lies. John 8:44. Can you imagine the government forcing words into your mouth? Whatever happened to Freedom of Speech in America?

We don't exactly know what the future may bring, but we wanted you to know that this attack has come against our ministry.

For years, DCO has been warning the American people of the dangers of pharmaceutical-drug based health care on our daily radio program — Daniel Chapter One Health Watch. Now, based on the FTC's unjust actions, we are continuing our "watchman" ministry — but using a new name, **Daniel Chapter One Censored**. Until we win our case in court, we can't answer health-care questions on air or share with you the healing qualities of God-given herbs, nutrients and foods. But we have worked especially hard to get all of our dietary and nutritional supplements in stock and to make them available and better than ever. **The full range of DCO products is still for sale**, and we urge you to show your support for DCO by your purchase at this difficult time.
